6/13/21	Burglary – Commercial	<p>At about 3pm at 32 E. Preston St., victim had checked on vacant location and realized rear basement door was forced open. Suspect entered but did not take anything.</p> <p><u>Suspect:</u> Unknown</p>
6/14/21	Carjacking	<p>At about 1:30 am at 1 E. Preston St., victim was working for door dash and arrived at location. Victim left friend in passenger seat with driver side door unlocked and car running while she delivered food. Suspect walked up to car and told the passenger to get out of car. Suspect got in car and fled.</p> <p><u>Suspect:</u> M/B/late 20's to early 30's Heavy set, light complexion Wearing black t-shirt, black gator over face sweats and black tennis shoes</p>
6/18/21	Burglary	<p>At about 6:15pm manager of building report that suspect entered victim's apartment, forced the front door open damaging it. Manager requested suspect be charged.</p> <p><u>Suspect:</u> Known – M/B</p>
6/20/21	Aggravated Assault	<p>At about 12pm at 38 W. Biddle St., suspect was allowed into victim's apartment to pick up items. Suspect got upset and grabbed victim and began to choke her. Victim locked herself in bedroom until police arrived. Suspect was talking about suicide. Suspect taken to hospital and release.</p> <p><u>Suspect:</u> Known - M/W</p>
6/21/21	Attempted Murder	<p>At about 2:40 in the morning in front of 1037 Cathedral Street, an altercation occurred between two individuals. One of the two individuals shot the victim. The victim suffered a gunshot wound and is expected to survive. The suspect fled.</p> <p><u>Suspect:</u> Unknown</p>
7/4/21	Burglary	<p>At about 11am at 1037 Cathedral St., victim reported no sign of forced entry but reported missing items.</p> <p><u>Suspect:</u> Unknown</p>



7/7/21	Burglary – Commercial	<p>At about 9am at 1013 Cathedral St., owner reported he left his keys in front door, came to work and found entry had been made by 2 suspects around 3am. Items were taken</p> <p><u>Suspect #1:</u> M/B/30's identity known <u>Suspect #2:</u> M/B/5'9" wearing face mask, black shorts, white sneakers, black t-shirt</p>
7/19/21	Assault & Robbery	<p>At about 7:30am at 100 W. Lanvale St., victim was riding his bike when suspect stepped in front of him, grabbed the handle bars and told him to get off. Suspect then demanded helmet. Suspect took the bike and helmet and fled.</p> <p><u>Suspect:</u> M/B age 36-43 5'6" 200lbs Wearing jeans, blue baseball cap, blue face mask.</p>
7/19/21	Burglary	<p>At 1010 St. Paul St., victim left apartment for about 8 hours and left door unlocked. When he came back he found a number of items missing.</p> <p><u>Suspect:</u> Unknown</p>
7/23/21	Burglary	<p>At about 12:30pm at 1222 N. Charles St., victim came home and found front door had been forced open and suspect was in the kitchen cooking. Police were called and suspect taken into custody for emergency petition.</p> <p><u>Suspect:</u> Homeless M/B age 42</p>
7/27/21	Burglary – Commercial	<p>At about 9am at 9 E. Mt. Royal Ave., tenant viewed video and reported that suspect used a knife to pry the side door to garage and entered. Suspect took bike from garage.</p> <p><u>Suspect:</u> M/B/26 6'4" Bald Wearing white t-shirt, jean shorts, white shoes</p>
7/29/21	Aggravated Assault	<p>At about 5:30pm at 1209 N. Charles St., suspect got into argument with female employee. She followed employee to back room and began throwing metal pans hitting another employee.</p> <p><u>Suspect:</u> ARRESTED</p>



8/3/21	Burglary	<p>At about 5pm at 1303 N. Charles St., victim came home and found entry had been made through rear 2nd floor window off the fire escape. Victim's tv had been taken.</p> <p><u>Suspect:</u> Unknown</p>
8/5/21	Armed Assault & Robbery	<p>At about 1:00am at 1027 Cathedral St., suspect came to victim's location while intoxicated. An argument ensued and suspect threw a metal pot at victim. He also punched the victim several times.</p> <p><u>Suspect:</u> M/B 20's 5'8" had goatee</p>

8/20/21	Burglary	<p>At about 10:30pm at 1303 N. Charles St., victim came home as was advised that neighbor saw suspect leaving his apartment. Victim checked and nothing was missing. He stated that his rear window was open which is normally locked. No evidence of forced entry.</p> <p><u>Suspect:</u> M/B</p>
