9/1/21	Assault & Robbery	<p>At about 4am at 1100 N. Charles St., victim asked suspect #1 to drive her to ATM machine. Victim return to car, suspect #1 grabber her bank cart, suspect #2 grabbed victim's purse and suspect #3 pulled victim out of car.</p> <p><u>Suspect #1:</u> Known to victim. Arrest Warrant obtained</p> <p><u>Suspect #2:</u> M/B Had a beard and sideburns</p> <p><u>Suspect #3:</u> M/B Wearing all black clothing</p>

Employee approached suspect, suspect pulled out a sharpened screwdriver and threatened employee.
