1/6/21	Aggravated Assault	<p>At about 11:30am at 1 E. Mt. Royal Ave., victim received a call from ex-boyfriend to help look for his phone. When she got there, the suspect, the ex-boyfriend's new girlfriend, walked up to the victim and punched her in the face, then maced her and fled the scene.</p> <p><u>Suspect:</u> F/B Delbvara Macklin</p>
1/6/21	Aggravated Assault	<p>At about 5:00pm at 1100 N. Charles St., the victim, a homeless male, was sitting on steps of location when suspects began to throw bricks at him. The victim was struck by several bricks.
