

Enroll in a Course via the Academic Advisement Report (Degree Audit)

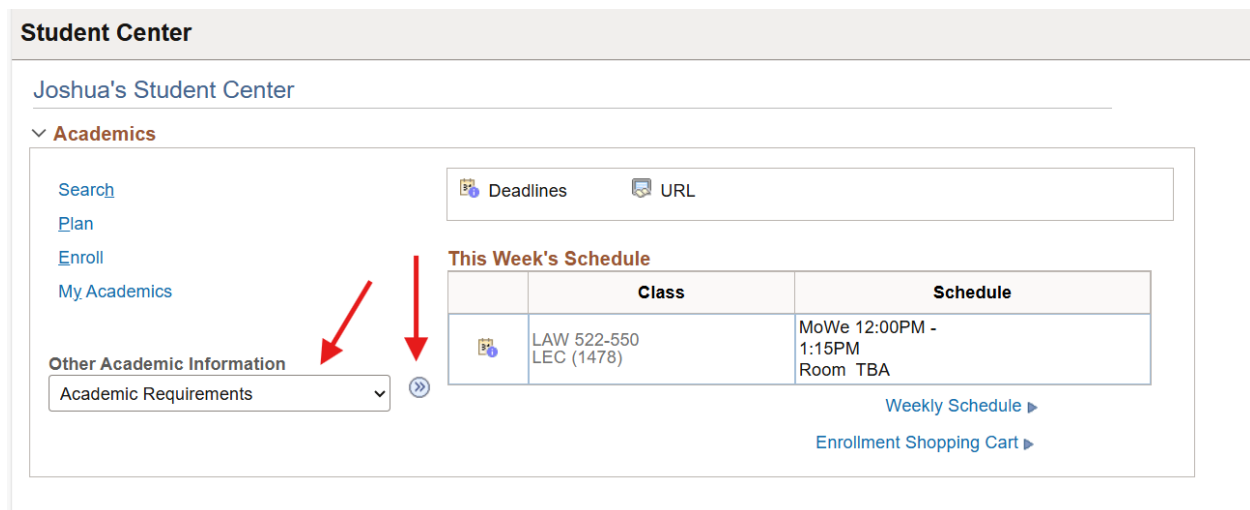
(This tutorial explains how to enroll in a course from your Academic Advisement Report through Self Service.)

Navigate to the MyUB Homepage by going to the following link:
<https://myubalt.ubalt.edu/>. Enter your Network ID and Password.

From the MyUB Portal, select “My Student Center” from the “Most-Used Tools” column.



Under the “Academics” tab of your Student Center, select the drop-down option under the “Other Academic Information” field. Select “Academic Requirements,” then click the two corresponding arrows next to the option to proceed.



On the next page, under the “My Academic Requirements” section, select the option to “Expand All” to review Graduation Requirements, Core Requirements, and Courses Not Used.
