

Waitlisting a course

(This tutorial explains the waitlist process and how to waitlist a course.)

During the enrollment process, you will notice that each course has a “Status.”



“Open” indicates seats are available in the course.

“Closed” indicates seats are not available in the course.

“Wait List” indicates seats are NOT currently available, but the student can be placed on a waitlist.

Important Wait List Information

When a seat becomes available you will automatically be added to the course. Students do not receive notification that they have moved up to another position on the waitlist.

Please note the following reasons you will not be moved off the wait-list into a class.

1. Time Conflicts (with another course, even a course you are “holding tentatively” in case you don’t get in)
2. Enrollment in another section of the same course
3. Enrolled in the maximum allowed credits
4. Holds on your record: initial enrollment hold, accounting hold, etc.

Even if you are number 1 on the waitlist, if one of these circumstances is present, the next available seat in the class will go to the next person on the waitlist. Please monitor your position on the waitlist closely so that you will not lose your seat to someone who does not have one of the conflicts outlined above. Once you are moved into the course your financial account will be adjusted accordingly.
