University of Baltimore UBalt CARES Grants Direct Aid to Student Cumulative Quarterly Report April 10, 2022

As per US Department of Education guidance - the University of Baltimore submits an initial 30-day report, following our April 21, 2020 submission of CARES Act application and certification for funds allocated under 18004(a)(1).

- 1. The University of Baltimore (UBalt) acknowledges that the institution signed and returned to the Department the Certification and Agreement on April 21, 2020 and assures that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students. UBalt acknowledges receiving two supplemental grants. The Coronavirus Response and Relief Supplemental Appropriations Act (CRRSSA/HEERF II), 2021 Supplemental Agreement (CFDA 84.425E) ((a)(1) Student Aid Portion) on March 20, 2021 and the America Rescue Plan (ARP/HEERF III) on June 11, 2021.
- 2. The total amount of funds the institution received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students, which for UBalt received is <u>.\$6,106,086</u>:

- 3. The total cumulative amount of UBalt Cares Grants distributed to students under Section 18004(a)(1) of the CARES Act is **\$4,934,071.59** through **March 31, 2022**. The total amount disbursed for the quarter ranging from January 1, 2022 to March 31, 2022 is \$1,111,165.10. UBalt's reporting dates were May 21, July 6, and August 21, 2020. Beginning September 30, 2020, quarterly reports will be published on October 10, 2020, January 10, April 10, July 10, 2021, and each quarter thereafter unless the Secretary specifies an alternative method of funding.
- 4. UBalt estimated the total number of students at the institution eligible to participate in

programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act to be:

- 2,523 **on May** 8, 2020, for the spring 2020 semester.
- 464 **on June** 10, 2020, for the summer 2020 semester.
- **2,221 on September** 9, 2020, for the fall 2020 semester.

- **5.** The total number of students who have received a UBalt CARES Act to students under Section 18004(a)(1) of the CARES Act is 1,9 2 2.
- 6. UBalt used the following methods to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act. :
 - A student must be currently enrolled or was enrolled at least half-time (6 or more credits) in a Title IV eligible UBalt degree or certificate program for spring 2020 semester on or after March 13, 2020.
 - A student must not have been enrolled in an exclusively online program on or before March 13, 2020.
 - The Coronavirus Response and Relief Supplemental Appropriations Act, 2021 Supplemental Agreement (CFDA 84.425E) ((a)(1) Student Aid Portion) removed this requirement and went into effect as of December 27,2020.
 - A student must be me meeting Satisfactory Academic Progress (SAP) requirements.
 - A student must have filed a 2019-2020 Free Application for Federal Student Aid (FAFSA) for spring and summer 2020 semesters or a 2020-2021 FAFSA for the fall 2020, spring 2021, and summer 2021 semesters-and have met the criteria as outlined in section 484-Title IV of the Higher Education Act of 1965 to participate in Title IV programs.
 - For the fall 2021 and spring 2022 semesters a student must have filed a 2021-2022 Free Application for Federal Student Aid (FAFSA) except for international students, who were eligible to apply for a grant if they met all requirements other than completing a FAFSA Appli cation .
 - In order to receive emergency grant funding, eligible students must apply online through the UBalt CARES Act application to explain and certify how they were affected by the disruption of campus operations in one or more of the following allowable cost of attendance components: food, housing, course materials, technology, healthcare, and child care.
 - Submitted applications are reviewed by selected staff members within the Office of Financial Aid (OFA) and approved grant amounts are determined using a modified version of the 2019-2020 Cost of Attendance (/admission/financial-aid/aid-basics

/2019-202o_COA_Estimates.pdf) (spring/summer 2020 semesters), 2020-2021 Cost of Attendance (/admission/ financial-aid/ aid-basics/ 2020-2021_COA_Estimates.pdf) (fall 2020, spring 2021, and summer 2021 semesters), and the 2021-2022 Cost of attendance (ladmission / financial-aid/ aid-basics / 2021-2022 Cost of Attendance.pdf) (fall 2021 semester).

- The minimum grant amount is \$300, and the maximum grant amount was \$1,500 for the spring 2020, summer 2020, fall 2020, spring 2021, and summer 2021 semesters. For the fall 2021 and spring 2022 semester the maximum grant amount was \$2,000.
- For the spring 2020 semester, UBalt set a priority consideration date of May 17, 2020, and a deadline for submission of applications as May 22, 2020.
- For the summer 2020, fall 2020, spring 2021, summer 2021 semesters, fall 2021, and spring 2022 semester, the application was available to students the first day of the term, and applications were reviewed after the term add/drop dates.
- Beginning on August 26, 2021 students in good academic standing that had completed a 2020-2021 FAFSA Application were notified via email of the option of complete a HEERF Authorization Form to have HEERF funds applied directly to their outstanding balances. The maximum amount applied was \$3,000 per student.
- Approved grants are processed through the Comptroller of Maryland as check to the students' local address on file or by direct deposit if the student has enrolled.
- 7. The following steps were taken by UBalt to provide instructions, directions, or guidance to students concerning the UBalt CARES Grant:
