
What is Pre-Law at UBalt

While Pre-Law is not an official 'major' at the University of Baltimore, multiple majors are connected to this designation. These majors cross the various colleges at UBalt. Pre-Law is focused on providing routes to UBalt School of Law for interested students and on providing insights into alternate law-related careers.

Pre-Law Paths & Options

Students that fall in the Pre-Law designation are likely to find themselves in one of two categories: students planning to pursue law school in order to begin a career in law, or students interested in a law-related career but not necessarily planning to go to law school. Depending on your interests, either of these paths could be effective in getting you where you want to go. The resources available to you here at UBalt can also assist you in navigating these decisions and options.


Of the opportunities listed above, one to take note of is the Court Navigator Program offered through UBalt and the Baltimore City District Court. This program allows undergraduate, graduate, and law students to gain experience as court navigators by helping unrepresented people navigate the steps of the court process. Among the responsibilities of court navigators include providing tenants with information about legal options, assisting with completing court forms, going with them to courtroom hearings, and aiding in follow-up steps.

Law School
