

Preface

It is my privilege to present this year's Factbook to our university community. Emerging from the first 100 days of the newly established Office of Institutional Effectiveness, the Factbook offers an overview of our university's demographics, academic programs, and student success. It aims to unify our understanding of ourselves, support evidence-based discussions and inspire further inquiries.

Here are some highlights from the Factbook:

- Eor Fall 2024, enrollment of 3,101 students was distributed as follows: Yale Gordon College of Arts and Sciences 29%, College of Public Affairs 25%, Merrick School of Business 23%, and School of Law 23%. (pages 38-39)
- The second-year retention rate rose by 4 percentage points for first-time undergraduates, transfer, and law students, and by 6 percentage points for graduate students last Fall. (pages 21-26)
- The 6th year graduation rate for first time full time undergraduate students reached 47% last year, the highest in the freshman program's history. (page 27)
- •In the Fall 2023, 15% of undergraduate students and 24% of graduate students registered exclusively for in person classes. (page 65)
- •The percentage of law students who have Maryland residency has been steadily decreasing, reaching 71% in Fall 2023. (page 63)
- •Over the last year, 60% of staff and 47% of faculty self-identified as female. (pages 82, 85)

The Factbook's figures are based on the 2023-2024 reporting of the Office of Institutional Effectiveness and adhere to external reporting requirements from accrediting bodies and governmental agencies. Definitions and methodologies may differ from those used by Enrollment Management, Administration and Finance and other internal teams. To provide clarity on such differences, we have added explanatory notes and references to other offices' reports where applicable. Different approaches are valid and when understood in context, enhance transparency and ensure a nuanced understanding of our community. If the reader encounters a data point in the Factbook that appears to contradict a report published elsewhere, please communicate with the Office of Institutional Effectiveness. The clarification of a question or doubt from one reader may provide the opportunity for our office to clarify the same for the community at large.

Thank you to all faculty, staff, and administrators who contributed to the Factbook's compilation and review. Your efforts ensure accurate and relevant institutional data, supporting our collective progress towards achieving our mission.





2nd Yr Retention Rates for All Lower Division New Transfers






Retention Rates for All New Transfers (Full time + Part time)



Credit Hours Earned as a Percentage of Attempted








YOY Percent Decline in Fall University Enrollment











Undergraduate Programs with the Highest Fall 2023 Enrollment in Merrick School of Business





Graduate Programs with the Highest Fall 2023 Enrollment in Merrick School of Business








Law School Headcount Enrollment By Day and Evening Programs






Degrees Conferred by Career and School/College: College of Public Affairs




Degrees Conferred by Career and School/College: Merrick School of Business
