University of Baltimore Crime Statistics

UBalt's Annual Security Report (ASR) was prepared by the UBalt Office of Campus and Safety Security to comply with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act. The report includes statistics for the previous three years concerning certain specified crimes or incidents that have been reported to UMBPD (post- March 28, 2022), the University of Baltimore Police Department ("UBPD") (pre- March 28, 2022)¹, Baltimore Police Department ("BPD"), or identified campus security authorities and that occurred on campus; in certain off-campus buildings owned or controlled by UBalt; or on public property within campus, or immediately adjacent to and accessible from the campus. The ASR is prepared in cooperation with the UMBPD, Baltimore Police Department ("BPD"), and the University's Office of Student Success and Support Services.

Each year, an email notification is sent to all enrolled students, current faculty, and staff. This notification provides the website address to access this report. Copies of the report may also be obtained at the Office of Student Support, in Academic Center, Room 112. This same notification is also printed on employment applications, admissions applications, handbooks, and catalogs.

The Universities at Shady Grove (USG) is a Regional Center for the University System of Maryland (USM). Degree programs provided by 9 of the 12 USM institutions are offered at USG. Students from each of these 9 institutions attend classes at USG and in some cases may attend classes on USG and their home campuses.

Statistics listed in the "Public Property" category include those that took place off campus, on public property immediately adjacent to and accessible from the campus, but not on USG property.

3	Hate Crimes are crimes that manifest evidence that the victim was intentionally selected because of the victim's actual or perceived Race (RA), Religion (RE), Sexual Orientation (SO), Gender (G), Ethnicity (E), Disability (D), Gender Identity (GI), or National Origin (NO). Any numbers in small-print parentheses would indicate how many of the total number of reported incidents were motivated by each type of bias.
4	Statistics on this chart are a summation of records requested and received from the Montgomery County Police Department (which includes all Rockville City Police Department records) and the Maryland State Police. This chart additionally includes all Clery reportable statistics reported to USG security officers or other Campus Security Authorities, including those reported to partner institution CSAs.
5	The Montgomery County Police Department does not classify crimes into this category. Statistics in this category will only be those reported or known by Campus Security Authorities or where enough information is known to allow classification.
6	Individuals not arrested, but referred for possible campus disciplinary action (e.g. first offenders required to attend educational programs.)
7	Unfounded reports are classified as unfounded based on the results of a full investigation and evidence conducted by sworn law enforcement personnel that determine the crime report is false or baseless. Daily Crime Log

The Office of Campus Safety and Security maintains a 60-day log of all crimes reported to UMBPD or the Office of Campus Safety and Security, and which occurred on UBalt's campus, non-campus, or public property, or within UBalt's patrol jurisdiction. The log lists the nature, date, time reported, location, and disposition. To obtain a copy of the daily crime log you can:

Reporting a Crime

Effective March 28, 2022, policing on the campus of UBalt is managed by UMBPD. Uniformed officers from UMB - sworn, armed, and professionally trained and certified - are assigned to patrol the UBalt campus. UBalt maintains responsibility for campus security performed by unarmed, civilian security personnel known as the UBalt Safety and Security team. The UBalt Safety and Security team also provides building access and control, including addressing office lockouts, welcome desk staffing, conducting interior/exterior patrols, etc. UMBPD and the UBalt Safety and Security team are in regular and constant contact.

All crimes, incidents or emergencies should be reported immediately and directly to the UMBPD at 911; to ensure inclusion in annual crime statistics and to aid in providing timely warning notices to the campus community. All crimes and incidents should be reported when a victim of crime elects to or is unable to make such a report. The offices of the UMBPD (410.706.6882) are located at 214 North Pine Street, Baltimore, MD 21201. Any campus member who is a victim of a crime is also encouraged to report the incident to the BPD.

A crime or incident may also be reported to a campus security authority (CSA), which includes, in addition to UMBPD and the UBalt Office of Campus Safety and Security, individuals who are responsible for monitoring entrances into institutional property, the Office of Human Resources or any official of the institution who has significant responsibility for student and campus activities, including, but not limited to, officials overseeing student discipline and advisors to students/student organizations. UMBPD will investigate and report to the appropriate authority all crimes in accordance with UMBPD policies and procedures.

Confidential Report:

If you are the victim of a crime and do not want to pursue action within the University or the criminal justice system, you may still want to consider making a confidential report. A confidential report, while protecting

your identity, affords UBalt an accurate record of incidents to determine threats to the campus community, and provides an opportunity to take a proactive approach to protecting the campus. Such reports shall be included in the annual crime statistics. Victim confidentiality is strictly observed.

Emergency Response Procedures

UBalt employs a redundant emergency communications and warning system. This system is designed to provide critical information to the campus community before, during and after an immediate emergency or threat. UMBPD shall confirm, through appropriate methods, that a state of emergency does, in fact, exist. The UMBPD Police Liaison assigned to UBalt shall initiate notification without delay unless it will compromise efforts to assist a victim or contain, respond to, or otherwise mitigate the emergency. The components of the campus communication protocol are activation of an emergency webpage dedicated to the incident, email and text message.

Timely Warnings

UMBPD works closely with the BPD to review current criminal activity and information, both on campus and on the UBalt public property area. If a situation comes to the attention of UMBPD and is considered by the University to represent a serious or continuing threat to the campus community, the UMBPD Police Liaison will issue a campus wide "alert" or safety bulletin without delay. The alert will be issued to all students, faculty, and staff via the following methods (list is not all inclusive):

- Broadcast email;
- Campus text alert system;
- Other communication methods that may be available

Anyone with information they believe warrants a timely warning should report the situation to the UMBPD at 410.706.6882, or in-person at the Police Communications Center located on the ground floor of the UMB Police Department, 214 North Pine Street, Baltimore, MD 21201.

Operational Authority

The UMBPD is a legislated police agency. University police officers are vested with full police authority under provisions of Title 13, Subtitle 6, Section 13-601, Education Article, Annotated Code of Maryland. In addition, police officers are granted additional jurisdictional authority as prescribed in the Criminal Procedure Act, Title 2, Subtitle 1, Section 2-102.

UMBPD works cooperatively with the BPD, and other law enforcement agencies to ensure an exchange of information related to personal safety issues on campus exists and is maintained. Moreover, this information exchange assists in compliance with local, state, and federal laws and regulations regarding campus safety issues. It is the policy of UMBPD to monitor crimes at non-campus facilities owned, leased, or controlled by UBalt, including student organizations officially recognized by UBalt, and report such incidents to the University community. UBalt has an Office of Campus Safety and Security comprised of non-sworn safety personnel.

UMBPD and BPD have an official memorandum of understanding ("MOU") and an excellent working relationship. Each department augments the other, within their respective jurisdictions, in all matters of mutual concern. University police regularly attend meetings with the BPD to exchange ideas and resolve problems which may be of concern for the campus community. The jurisdiction, as outlined in the MOU between UMBPD and BPD, extends north to Oliver Street; south to Chase Street; east to St. Paul Street; and west to Cathedral Street; approximately 16 square blocks.

Maintenance and Access to Campus Facilities

The Office of Facilities Management maintains the campus buildings and grounds with a concern for safety and security. Routine inspections are conducted to identify any changes in exterior lighting conditions. In addition, defective lighting conditions are reported as detected by other building service personnel and UMBPD officers. Ad hoc meetings between the Office of Facilities Management and the UMBPD are held to address other relevant safety issues or concerns.

Selected officers routinely conduct various surveys and forward reports to the appropriate department or agency. These surveys not only address existing conditions but also can include recommendations for improvements. Additionally, police and security officers report any safety hazard to the appropriate authority on or off campus. Any repairs that include security and safety implications are prioritized and handled accordingly.

UBalt welcomes faculty, staff, students, and visitors to its campus for use of UBalt facilities as available and scheduled by the university and in accordance with all applicable laws and policies. Faculty, staff, and students are issued identification cards. Everyone using the campus is required to show proper identification pursuant to policy and when requested by a police or security officer or by authorized personnel of the university.

All buildings are locked and secured by police and security officers in accordance with scheduled activities in the buildings. No unauthorized persons are permitted in the buildings during non-operational hours. Trespassing laws are vigorously enforced.

Sexual Misconduct Policy & Reporting Procedure

UBalt's Sexual Harassment and Other Sexual Misconduct Policy is available on the institutional website.

The UMBPD has instructed its personnel, while investigating or becoming aware of a sexual assault, domestic violence, dating violence or stalking incident (s) involving a campus member, all UMBPD personnel are authorized to advise the victim/complainant of their right to file a Title IX sex discrimination complaint with the university in addition to filing a criminal complaint, and to report such incidents of sexual violence to Pavan Purswani, Title IX Coordinator (410.837.5414), Office of Student Support and the Dean of Students (410.837.4755), Office of Human Resources (410.837.5410), or email t9@ubalt.edu if the victim/complainant consents.

Law Enforcement Reporting Procedure and Protocols

Victims are encouraged to report any incident of sexual assault, domestic violence, dating violence, stalking or any criminal act.

Victims of sexual assault, domestic violence, dating violence or stalking are urged to contact law enforcement or medical personnel as soon as possible following the occurrence to receive guidance in the **preservation of evidence needed for proof of criminal assaults** and the apprehension and prosecution of assailants. Through its concurrent Jurisdiction and Mutual Aid Agreement with the BPD, UMBPD has access to the BPD crime laboratory resources and other investigating units upon request.

It is important to report the incident immediately and to preserve all physical evidence. Regardless of whether the incident occurred on or off campus, when a report is made to the Title IX Coordinator or a Title IX Team Member, they will provide the student or employee with the Sexual Harassment and Other Sexual Misconduct policy.

Victims or witnesses may make a voluntary, confidential crime report for inclusion in the annual crime report.

Reporting of sexual assault, domestic violence, dating violence or stalking to Non-Campus Authorities

When a report of sexual assault, domestic violence, dating violence or stalking is made to the institution's initial contact, that person will encourage the victim to contact the BPD and medical personnel as soon as possible following the incident to receive guidance in the preservation of evidence needed for proof of criminal assaults and the apprehension and prosecution of assailants. Campus authorities will help notify non-campus authorities at the request of the victim. UMBPD also monitors non-campus crime through cooperation with the BPD.

Additionally, campus personnel will retain the right to contact law enforcement personnel directly where an issue of campus security is involved. Campus personnel will also assist the victim in obtaining medical attention, if the victim chooses, including providing transportation to the Mercy Medical Center or other hospital capable of performing a Sexual Assault Forensic Exam ("S.A.F.E.").

What To Do If You Are a victim of sexually assault, domestic violence, dating violence or stalking

- Get to a place where you will be safe from further attack. For your own protection, call the police immediately, especially if the assailant is still nearby. The police will help you decide whether to file charges against the assailant.
- Call a friend or family member for support.

If you are the victim of a sexual assault:

• **Get medical attention immediately.** If you have been sexually assaulted, a medical examination will check for physical injury, the presence of sexually transmitted diseases or pregnancy because of the assault. A medical examination will also aid in the police investigation and legal proceedings.

- Do not bathe or douche. Bathing or douching might be the first thing you want to do. However, you will be washing away valuable evidence. Wait until a doctor has examined you.
- Save your clothing. It is all right to change clothes. But save what you were wearing. Your clothing could be used as evidence for prosecution. Place each item of clothing in a separate paper bag for the police.
- Report the incident to the police. Reporting a rape is not the same thing as filing charges for a rape.
- Filing charges can be determined later. To contact UMBPD, call 410.706.6882, 24 hours a day. Many campus personnel are willing and able to assist victims in reporting assaults to the proper authorities.

If you are the victim of domestic violence, dating violence, or stalking:

- Take steps to preserve any evidence that may aid in any administrative action and/or criminal prosecution that may result.
- Examples of items that may serve as evidence would be:
 - Any recorded media such as voicemails, emails, text messages, Facebook, or other social media messaging.
 - You should also preserve any other notes, writings, correspondence, etc., that may be relevant to the case.
 - Depending on the situation, clothing worn by the victim and/or suspect may also be needed as evidence and therefore should be preserved in its original state.
 - Do not disturb the scene of any domestic/dating violence incident as police may want to photograph the scene upon their arrival. They will also want to photograph any injuries that are immediately apparent or that may appear days later.
 - If any weapon was used or any object was used as a weapon, leave it in its original position and do not touch it until police arrive.

As the victim of an incident of sexual assault, domestic violence, dating violence, or stalking, you have the right to decline to notify law enforcement. Regardless of your choice to notify law enforcement, please secure medical attention, and contact any of the victim support resources listed below. The campus will also assist the victim with contacting any of these supporting agencies.

The University will assist the victim, at their request, in notifying the appropriate law enforcement authorities to file criminal charges. The University will also provide full and prompt cooperation in accessing the appropriate medical attention for the victim, including transportation to a hospital equipped with a sexual assault evidence collection kit.

Complaints of sexual assault, domestic violence, dating violence or stalking that fall within the jurisdiction of the University's Sexual Misconduct and other Sexual Harassment will be adjudicated in accordance with that policy and the disciplinary procedures therein. Both the victim and the accused will be allowed to have witnesses present during the hearing process and will be notified of the outcome of the university disciplinary process.

UBalt endeavors to protect the confidentiality of the victim and other necessary parties, in compliance with legal obligations. For example, UBalt will complete publicly available recordkeeping, such as its Annual Security Report and Daily Crime Log, without the inclusion of personally identifiable information of the victim. Further, UBalt will maintain as confidential any accommodations or protective measures provided to the victim to the extent that maintaining such confidentiality is compliant with all applicable laws and would not impair the ability of UBalt to provide the accommodations or protective measures. UBalt is also committed to affording protection against reprisal to all parties involved in the university disciplinary process and providing due process to those accused of violations.

An educational and informational campaign to help prevent sexual assaults, domestic violence, dating violence or stalking will be available to students, faculty, and staff. The educational programs are provided through various formats, which address the issues germane to sexual assault and its prevention, including **domestic violence**, **dating violence or stalking**, and self-defense. In addition, there are free pamphlets available on all these topics.

Victim's Services

Victims of sexual assault, domestic violence, dating violence or stalking have access to counseling through the Student Assistance Program (SAP) and Employee Assistance Program (EAP). After an incident of sexual assault, domestic violence, dating violence or stalking has been reported, the university will notify the victim of the right to request an alternative academic or employment situation if such an alternative is available, feasible, and appropriate to the facts of the reported assault.

<u>Student and Employee Disciplinary Procedures for Matters Alleging Sexual Assault, Dating Violence, Domestic Violence, or Stalking</u>

Violations of law and university policies and regulations regarding sexual misconduct may be subject to prosecution through both legal and civil authorities, and the university disciplinary system. There are a range of university penalties for a violation of university policy, which include: reprimand up to and including dismissal, termination, and expulsion.

The university procedures guarantee that:

- the complainant and the respondent are entitled to the same opportunities to have others (e.g., witnesses, advisors) present during a university disciplinary proceeding;
- both the complainant and the respondent shall be informed of the outcome of any university disciplinary proceeding; both parties will receive a document summarizing the hearing officer's findings;
- the complainant and the respondent will be treated with dignity, courtesy, and professionalism;
- that while the offense may need to be reported according to federal reporting mandates and Maryland law, the university will endeavor to honor the victim's wishes regarding whether to proceed under university policy but may be required to do so in certain instances, and
- both complainant and respondent will have the opportunity to present witnesses and evidence for consideration during an investigation.

Sexual Misconduct Awareness - Educational and Counseling Programs

The university offers educational programs for the awareness and prevention of sexual offenses and counseling services for the victims and survivors of sexual assaults, domestic violence, dating violence or stalking.

The university community is notified of services through prevention programs, university publications, flyers on bulletin boards, and by calling the Office of Student Support for specific information.

In cooperation between the Center for Student Involvement and the UMBPD, a Rape Aggression Defense Program (RAD) is offered to employees and students by a UMBPD officer, certified as a RAD instructor.



Persons wishing more information are encouraged to contact UMBPD, the Title IX Coordinator, the Center for Student Involvement and/or the Office of Human Resources.

Primary Prevention and Awareness Strategy for Incoming Students and Employees

With data from the National Institute of Justice showing that one in five college women and one in sixteen men will experience some form of non-consensual sexual activity by graduation, the widespread impact of sexual violence on students presents an urgent and pressing challenge for our nation's campuses. UBalt provides an online training system, <u>Vector Solutions</u>, for students and employees. Various training options addresses the critical issues of sexual assault, relationship violence, and stalking, which impact countless college students across the country.

Vector Solutions uses a population-level approach to educate all students on the issues associated with sexual assault and relationship violence, considering their unique perspectives and experiences, providing:

- Key definitions and statistics
- Reflective and personalized content
- Bystander skill and confidence-building strategies
- Campus-specific policies, procedures, and resources
- Rich data summaries to inform future programming

Orders of Protection

UMBPD shall assist with the adherence to any orders of protection, no contact orders, restraining orders, or similar lawful orders issued by a court and brought to the University's attention.

Victims may also seek a peace order from the District Court in accordance with the provisions of Title 3, Subtitle 15 of the Courts and Judicial Proceedings Article of the Maryland Code, or a protective order or temporary protective order in accordance with Title 4, Subtitle 5 of the Family Law Article of the Maryland

Code. Any victim who obtains a peace order, protective order, temporary protective order, or similar order issued by a civil or criminal court should notify the UMBPD (and provide a copy of the order), so the police department may take steps to enforce the order on campus.

Additionally, no contact orders can be issued by the University if applicable pursuant to university policies and procedures.

Campus Sex Crimes Prevention Act

Various statutes, including the federal Campus Sex Crimes Prevention Act and Section 121 of the Adam Walsh Child Protection and Safety Act of 2006 (42 U.S.C. 16921) require higher education institutions issue a statement advising the campus community where law enforcement agency information provided by a state concerning registered sex offenders can be found. It also requires sex offenders already required to register in a state to provide notice, as required under state law, of each institution of higher education in the state at which the person is employed, carries on a vocation, volunteers their services, or is a student. Maryland sexual offender registration information, including registrants employed or enrolled at Maryland higher education institutions can be found at:

You can perform a general search or enter the main campus address (e.g., 1420 North Charles Street, Baltimore, MD 21201) to view sex offenders within the vicinity of the university. Also, through the Maryland Sex Offender Alert Line, you can receive a phone call when a convicted sex offender moves into your zip code. Call the Maryland Sex Offender Alert Line at 1.866.559.8017 and enter your phone number and zip code. When the Department of Public Safety and Correctional Services receives notice that a registered sex offender is moving into that area, you will receive a notification call. You will then be directed to the Maryland Sex Offender Registry at https://dpscs.maryland.gov/onlineservs/socem/default.shtml for more information.

Safety and Security Awareness and Crime Prevention Programs

SAFETY AND SECURITY AWARENESS:

Every semester, as part of orientation for students and new employees, the services offered by the UMBPD are explained. Video, PowerPoint, and lectures outline ways to maintain personal safety on and off campus. Security awareness programs and crime prevention programs are offered continually throughout the academic year or upon request.

A common theme of awareness and crime prevention programs is to encourage the campus community to be aware of their responsibility for their personal security as well as the security of other members of the campus community. UMBPD's overall message to the students, faculty and staff is to "act as an extra pair of eyes and ears," and report anything that makes them feel uncomfortable or looks suspicious. If you see something, say something: REPORT IT!

R.A.D. stands for Rape Aggression Defense and is a self-defense class for men and women. This course will teach basic self-defense techniques and emphasize common sense approaches to safety on campus. Classes are taught by certified instructors from URecFit and UMB Police.

Policies on Drug and Alcohol Use

University of Baltimore IV.1.1 Policy on Drug and Alcohol Use

General Policy Statement

The use or abuse of controlled or illegal substances, and alcohol, pose a serious threat to the health and welfare of a large segment of the college student population through a lessening of academic performance, estrangement of social relations, creation of mental health and physiological problems, vandalism, and in some cases bodily injury, illness, and death. The University of Baltimore drug and alcohol policies are designed to help protect the health and welfare of students, observe state, federal and local laws and maintain an atmosphere and environment appropriate for learning.

Amnesty Policy

The health and welfare of our community is the University's primary concern. Any student who seeks help for themselves or another person during a medical emergency while under the influence of alcohol and/or drugs will not be charged by the University with a violation of University policy for being under the influence. Additionally, the person for whom help is sought will not be charged with a violation of University policy for being under the influence.

Health Risks

Substance abuse is recognized as the number one public health problem in the United States accounting for about 150,000 deaths annually. This includes deaths from stroke, disease of the heart and liver, and all alcohol and drug related suicides, homicides and accidents. About 30 percent of all those admitted to general hospitals and 50 percent to psychiatric hospitals have detectable substance abuse.

Treatment/Referral

Those interested in discussing drug or alcohol problems are encouraged to contact the University of Baltimore Office Of Student Support (AC 112) to review our resources that may assist you. In addition, the Student Assistance Program (SAP) is a service that provides private and confidential counseling services 24/7. They provide in person, online and/or by phone appointments.

Drug Policy

The University of Baltimore is committed to using all available means to prevent illegal activities on campus. Use, possession, sale, distribution, and being under the influence of controlled substances on university premises or at university-organized activities is strictly prohibited.

Commentary:

Please be advised that despite recent legislation in Maryland, which partially legalized the possession and use of cannabis for adults 21 and older, the use, possession, sale and distribution of cannabis remains prohibited on University property. While Maryland law partially legalized cannabis for those 21 and older, it remains a controlled substance under federal law and the University is obligated to comply with the federal Drug-Free Schools and Communities Act. Under Maryland law, use of cannabis in public spaces also remains illegal.

Those who have medical cannabis certificates are also prohibited from using cannabis on university property. Students should direct any questions or concerns to the university's <u>Office of Disability and Access Services</u>, and employees should direct any questions or concerns to <u>Human Resources</u>.

Violations

Violations of laws and university policies and regulations regarding the use of controlled/illegal substances and alcohol at on-campus or university-organized activities off-campus are subject to prosecution through both law enforcement authorities and the campus judicial system. Penalties through the latter authority will depend on a careful review of the facts and circumstances of each individual case, but

will take into consideration such factors as the accused person's previous record, the nature of the substance, and the degree of culpability. The range of university penalties shall include, but not be

limited to, disciplinary reprimand, loss of privilege, restitution, disciplinary probation, disciplinary suspension, disciplinary dismissal, and disciplinary expulsion.

Legal Sanctions

Students and employees at the University of Baltimore are subject to federal, state and local laws regarding the possession and distribution of illegal drugs. *Federal Law 21 USCA*, *sections 841 and 844*, states that it is unlawful to possess, manufacture, distribute or dispense a controlled substance. In addition, the state of Maryland has additional laws dealing with distribution, manufacturing, and possession of controlled substances. Maryland law (Sections 5-601, 5-602 and 5-607, Criminal Law Article) states that any persons who unlawfully manufacture, distribute, dispense 3 or possess a controlled dangerous substance may be subject to imprisonment up to 5 years and fines up to \$25,000. Maryland. Ann. Code Art. 27, section 286 (1989), further states that any person who unlawfully manufactures or distributes any controlled dangerous substances may be fined up to \$25,000 and may be imprisoned for up to 20 years for a first offense.

Federal law 21 USC, sections 841 and 844–845a (1990), states that it is unlawful to possess any controlled substance for any illegal purpose. If the substance is cocaine, or contains a cocaine base, the penalty for simple possession is a fine and/or imprisonment from 5 to 20 years. For other illegal drugs, the penalty for simple possession is a fine of at least \$1,000 and/or imprisonment for up to 3 years. The penalties increase if the possession includes intent to manufacture, distribute, or dispense a controlled substance, especially if done so near a public or private elementary, vocational, or secondary school, or a public or private college or university. Additionally, any person who violates this law shall also be liable to the United States for an amount up to \$10,000 in civil penalties.

Convictions related to controlled and/or illegal substances will adversely impact a student's ability to receive federal financial aid. Also, in Baltimore City, under *Article 19*, *section 58C of the City Code*, it is illegal to loiter in a certified drug-free zone, with penalties of imprisonment of up to 30 days and a fine of up to \$400.

Alcohol Policy

The University of Baltimore permits the use of alcoholic beverages in designated areas on campus if such use is in conformity with all applicable alcoholic beverage laws and the specific university regulations. The use of alcoholic beverages on campus or at off-campus university sponsored events must also be consistent with the maintenance of a high standard of conduct conducive to learning.

Violations

Violation of any regulation regarding alcoholic beverages will be adjudicated through the university's judicial system, and where appropriate, through legal action. Students and organizations found to be in violation shall face a range of university sanctions as provided in the

Code of Conduct, including but not be limited to, disciplinary reprimand, loss of privilege, restitution, disciplinary probation, disciplinary suspension, disciplinary dismissal, and disciplinary expulsion.

Legal Sanctions

Students and employees of the University of Baltimore are subject to state laws for possessing, consuming and obtaining alcohol. It is illegal in the state of Maryland for any person under 21 to falsify or misrepresent his or her age to obtain alcohol or to possess alcoholic beverages with the intent to consume them. It is also illegal in most situations to furnish alcohol to a person under 21 or to obtain alcohol on behalf of a person under 21. The penalty is a fine of up to \$500 for a first offense and up to \$1,000 for repeat offenses. Under section *TR16-113 of the Maryland Annotated Code*, licensees under the age of 21 years are prohibited from driving or attempting to drive a motor vehicle while having alcohol in the licensee's blood. Violation of this license restriction may result in a license suspension or revocation and/or a fine.

All sales, distribution, and consumption of alcoholic beverages, must conform to regulations of the university as set forth herein, to the regulations of the Board of Liquor License Commissioners for Baltimore City, and the laws of the state of Maryland. Specifically, *Article 2B* of the Annotated Code of Maryland (Alcoholic Beverages Law):

- 1. Prohibits selling or permitting consumption of alcoholic beverages after the prescribed hours (Section 86);
- 2. Prohibits permitting any person to drink any alcoholic beverage not purchased from the license holder on the premises covered by the license and not permitted by the license to be consumed on the premises (Section 114);
- 3. Prohibits selling or furnishing any alcoholic beverages to a minor or a person visibly under the influence of any alcoholic beverage (*Section 18*). The City of Baltimore Liquor Board requires that a one-day liquor license be obtained and displayed at any event where beer and wine are sold (Liquor Board Rules and Regulations Rule 1.10) or that a caterer with off-sale caterer privilege be used (Liquor Board Rules and Regulations Rule 1.09).

Regulations for the Marketing, Sale, Distribution, and Consumption of Alcoholic Beverages at University Events

All state, federal and local laws must be observed when marketing, selling and consuming alcoholic beverages.

Designated Areas

Alcoholic beverages may only be served and consumed in areas designated and approved by the Office of Auxiliary Services. For any events involving alcohol sold by student organizations, a

request to serve alcoholic beverages must be submitted to and approved by the Center for Student Involvement for undergraduate and graduate student organizations and by the School of Law for law student organizations at least thirty days prior to the event.

Precautionary Measures

Individuals or organizations sponsoring events on or off-campus are to implement precautionary measures to ensure that alcoholic beverages are not abused, accessible, or served to persons under the legal drinking age (21) or to persons who appear intoxicated. Such measures shall include but not be limited to: identification and age verification checks, wristbands or hand stamps identifying those eligible to drink alcoholic beverages, having designated servers distribute all alcoholic beverages, prohibiting any form of drinking "contest" or game, restricting distribution of free and inexpensive alcoholic beverages, informing and arranging for UMB police to be on-call for all events, and having non-alcoholic beverages and food available where alcoholic beverages are served.

Advertising/Promotion

Promotional materials including advertisement of university events may not:

- 1. Refer to the amount and price of alcoholic beverages (such as the number of beer kegs available),
- 2. Encourage any form of alcohol abuse,
- 3. Place emphasis on quantity and frequency of use,
- 4. Associate alcohol consumption with the performance of tasks that require skilled reactions such as the operation of motor vehicles or machinery, or
- 5. Portray drinking as a solution to personal or academic problems of students or as necessary to social, sexual, or academic success.

All promotional materials shall note the availability of non- alcoholic beverages as prominently as alcohol. Alcoholic beverages may not be used as inducement to participate in a university/student organization sponsored event. Display or availability of promotional material for both on-campus and off-campus student organization events must be reviewed to ensure those materials comply with university alcohol policy. For undergraduate and graduate student organizations this review will be conducted by Director for the Center for Student Involvement or his/her designee, for law student organizations, this review will be conducted by the Office of Academic Affairs in the School of Law.

Campus Marketing Programs

Campus marketing programs which include controlled sampling are permitted but shall conform to all university alcohol regulations, including the availability of alternative nonalcoholic beverages and food. No uncontrolled sampling as part of a campus event is permitted. The consumption of alcoholic beverages shall not be the sole purpose of any promotional activity. Marketing programs should have educational value and subscribe to the philosophy of responsible and legal use of the products represented. Marketers shall support campus alcohol awareness programs that encourage informed and responsible decisions about the use or nonuse of alcoholic beverages.

Free Alcoholic Beverages

Alcoholic beverages may not be provided as promotions, free awards or prizes to individual students or campus organizations. Free alcoholic beverages may not be served at student organization sponsored events without prior approval from the Director of the Center for Student Involvement or his/her designee for undergraduate and graduate organizations and from the Office of Academic Affairs in the School of Law for law student organizations.

Student Organization Alcohol Procedure

Note: The procedure below applies to undergraduate, graduate, and law student organizations at the University of Baltimore.

If your organization is interested in providing beer and/or wine for an event, or if you're holding an event where alcohol is being served, please carefully review the procedures below and the university-wide alcohol policy available here. The procedures below are created to align with this university-wide policy.

Submitting an Alcohol Agreement Form

- Organizations must complete a formal request (Alcohol Agreement Form) for any events involving alcohol at least 30 days prior to their event.
- Undergraduate and graduate student organizations will submit the request through the Center for Student Involvement.
- Law student organizations will submit the request through the Office of Academic Affairs in the School of Law.
- Organization representatives are encouraged to schedule a meeting with a staff member in the Center for Student Involvement (undergraduate and graduate organizations) or the School of Law Office of Academic Affairs (law organizations) to discuss these policies and procedures in further detail and to address any questions.

These procedures apply to both on and off campus events hosted by student organizations whenever alcohol is served, whether the organization purchases alcohol or not.

To host an event where alcohol is served:

- Designate an Event Chairperson
- Reserve your event space (as outlined previously for on campus events).
- Request quote from a caterer with a liquor license.
- Ensure your advisor is available to be present at the event. At least one of the organization's advisors or advisor's designee is required to be present at the event.
- The requirement to have an advisor present is waived if ALL of the following apply:
 - Participants are purchasing their own alcohol, i.e. the student organization is not paying for or facilitating the purchase of alcohol.
 - The venue where the event is being held has a liquor license, is providing the alcohol and servers.
 - The event is held off campus.
 - An example of an event where an advisor would not need to be present is a happy hour held at a restaurant where the student organization is purchasing food but there is a cash bar for those in attendance.
- Complete the Student Organization Alcohol Agreement Form.
- Center for Student Involvement (undergraduate and graduate organizations) or the School of Law Office of Academic Affairs (law organizations), as well as the UB Police Department will review your request. You will receive a notification once your request to serve alcohol has been approved.
- Obtain an invoice from a caterer with a liquor license for the serving and providing the beer and wine.
- Complete and submit an Event Incident Report after the event.

Before the Event

• Event Chairperson: Student organizations wishing to hold an event where alcohol is served must designate an Event Chairperson. The event chairperson should be the key contact for this event, must be present for the duration of the event, and should abstain from consuming alcohol during the event. The designated Event Chairperson MUST complete all necessary paperwork prior to and after the function. The Student Organization Alcohol Agreement Form and Alcohol Event Incident Report can be found in CampusGroups. The Incident Report must be completed after every event where alcohol is served even if an incident did not occur.

- Types of Beverages: Beer, certain malted beverages and wine are the only alcoholic beverages permitted at events hosted on campus. For off-campus events, only beer, certain malted beverages and wine may be purchased by student organizations for consumption at the event. The sale of these alcoholic beverages may only be a single facet of the event, not the sole purpose.
- Procurement of Beverages: Alcohol must be procured through and served by a
 caterer with a valid liquor license. When required by UPD, Public Safety officers
 must be available to provide security. This may include overtime costs.
 Organizations will be provided notification if they need officers after completing the
 Student Organization Alcohol Agreement Form. If required, an estimate of this fee
 will be provided when the Student Organization Alcohol Agreement Form is
 approved.
 - Scheduling: Events including alcohol will not be scheduled, nor approved, during the period of final exams. This period includes both study days and exam days for the College of Public Affairs, the College of Arts and Sciences, the School of Business and the School of Law.
 - Approved areas for sale: University approved areas for the sale of beer and wine are the Academic Center lounge, BC-003, areas in the Student Center, Gordon Plaza, Law School 12th floor, 6th floor, lobby and lower lobbies. The Business School Atrium is available on a very limited basis with special approval from the Director of the Center for Student Involvement or their designee.
 - Publicity: Event advertising may not promote excessive drinking through graphics or text. Event advertising may not promote special pricing of alcohol. Reference to "beer" and "wine" must appear in the same size and manner as, or smaller than, the reference to non-alcoholic beverages and food or other flier information. All promotional materials related to events involving alcohol must be reviewed by the Director of the Center for Student Involvement (graduate and undergraduate organizations) or the Assistant Dean of Students (law organizations), or their designee.

During the Event

- Advisor: Both the event chairperson and the student organization's advisor
 or the advisor's designee (must be UBalt faculty or staff) must be present
 throughout the duration of events where alcohol is served unless ALL of the
 conditions listed in the introductory section of this policy are met.
- Serving Times: Alcohol may be served for a maximum of six hours and all

sales/distribution must stop 30 minutes before the end of the advertised event time. (For example, an event advertised until 11:00 p.m. requires sales and distribution to cease at 10:30 p.m.) No alcohol can be served at an event before 3PM.

- **Age Verification:** Age verification is required for all those consuming alcohol at all events. In addition, some type of visible identification designating who is ofage must be used, i.e.; hand stamps, wristbands.
- Wristbands/handstamps: Events where all attendees are over the age of 21 may be exempt from wristbands/handstamps as determined by the Director of the Center for Student Involvement or their designee (undergraduate and graduate student organizations) or from the Office of Academic Affairs in the School of Law (law student organizations). Exception requests must be requested in writing in the Student Organization Alcohol Agreement. Age verification is still required, even if the use of wristbands/handstamps is not.
- Serving alcohol at events: No individual other than the caterer may serve alcohol to any individual attending an event on campus that is subject to the Student Organization Alcohol Policy.

Pricing Requirements

Approved alcohol may not be sold at a price lower than the cost of the product and equipment. No reduced pricing is allowed, such as "two for one" or "3 for \$2.00" or "bottomless" which encourages excessive drinking and/or irresponsible behavior.

- No alcohol may be distributed for free. This includes before, during, and after the event. Alcohol may not be part of an all-inclusive price for an event. For example: You cannot sell a ticket to an event for \$5.00, which would include you can eat food and all the alcohol you can drink. An all-inclusive price can include a pre-stated number of drink tickets provided that the price charged is at least equal to the per-drink cost of the alcoholic beverages. For example, a \$10 entry fee could include all you can eat and 2 drink tickets, if the actual cost of alcohol breaks down to \$5 or less per drink.
- Sodas, water, or other non-alcoholic drinks must be made available in equal
 or greater quantities than that of the alcohol during the entire course of the
 event. They must be offered for free or at fair market price.
- A sufficient quantity of food must be made available during the entire course of the event. While sales of some items are allowed, some type of free food

must also be supplied, for the entire course of the event.

- For catered events, leftover alcoholic beverages must be returned to the caterer. Alcohol may not be taken "to-go" nor may remaining alcohol be sent home with event participants following the event.
- No individual other than the caterer may bring alcohol to any event on campus that is subject to the Student Organization Alcohol Policy.
- Exceptions to the pricing requirements of these guidelines may be approved at the discretion of the Director of the Center for Student Involvement (graduate and undergraduate organizations) or the Assistant Dean of Students (law organizations), or their designee. Exceptions must be requested in writing in the Student Organization Alcohol Agreement.

Annual Fire Security Report

The Annual Fire Safety Report was maintained through June 21, 2016, when UBalt discontinued campus-related housing. As such, there is no requirement to provide this reporting.
