## **Modification to the Solicitation:**

- 1. Section II, Statement of Work, on page 16 of 73, 2.4:
  ADD: "The University observes the following major holidays under this contract:
  New Year's Day, Martin Luther King Jr. Day, Memorial Day, Juneteenth,
  Independence Day, Labor Day, Thanksgiving Day, and Christmas Day."
- 2. Section II, Statement of Work, on page 29 of 73, 2.24 Major Repairs and Overhauls Parts, first paragraph:

**DELETE:** "When completing repairs and overhauls (exclusive of preventive maintenance) as designated by the University, the Contractor will be responsible for the procurement of all parts, equipment, and related materials to perform the repair. The vendor will be responsible for the procurement and cost of individual repair and replacement parts up to \$1,000.00 and the university will pay the excess over \$1,000.00. For example, if an individual replacement part costs the vendor \$1,500.00, the vendor will pay \$1,000.00 and the university will pay \$500.00 (1000 + 500 = 1,500). The threshold for the contractor's deductible expense shall be capped at \$15,000 per contract year; after which the deductible shall no longer be applicable." **and** 

REPLACE WITH: "When completing repairs and overhauls (exclusive of preventive maintenance) as designated by the University, the Contractor will be responsible for the procurement of all parts, equipment, and related materials to perform the repair. The vendor will be responsible for the procurement and cost of individual repair and replacement parts up to \$1,000.00 and the university will pay the excess over \$1,000.00. For example, if an individual replacement part costs the vendor \$1,500.00, the vendor will pay \$1,000.00 and the university will pay \$500.00 (1000 + 500 = 1,500). The threshold for the contractor's deductible expense shall be capped at \$25,000 per contract year; after which the deductible shall no longer be applicable."
