• December 2015 - CFCC's Truancy Court Program Receives \$47,025 grant from the Maryland Judiciary's Department of Family Administration

CFCC has received \$47,025 from the Maryland Judiciary's Administrative Office of the Courts, Department of Family Administration to support the operation of our Truancy Court Program (TCP). This funding supplements \$70,000 awarded earlier in the year, bringing the Department of Family Administration's total support of the TCP to \$117,025 for this fiscal year. We are grateful for our longstanding partnership with the Maryland Judiciary, whose funding of our Truancy Court Program began in 2008.

• December 2015 - CFCC's Truancy Court Program Receives \$25,000 grant from Open Society Institute—Baltimore

CFCC has received a \$25,000 grant from Open Society Institute—Baltimore to support the operation of the Truancy Court Program (TCP). We are grateful for this opportunity to partner with OSI-Baltimore, with whom we have worked closely for many years on attendance issues. The TCP has increased the number of schools where it operates the TCP this year in response to its success with students at the ninth grade level.

• December 2015 - CFCC Receives \$60,000 grant from the Charles Crane Family Foundation

CFCC has received \$60,000 from the Charles Crane Family Foundation to support the operation of the Truancy Court Program (TCP) in several Baltimore City Public Schools for the 2016–2017 academic year. • December 2015 - CFCC Partners with Maryland Department of Juvenile Services

• October 5, 2015-2016 Truancy Court Program (TCP) Underway

CFCC's Truancy Court Program (TCP) is working with four public schools in Baltimore City and one high school in Anne Arundel County for the 2015-2016 school year. This year's schools are Henderson Hopkins Elementary/Middle School, Reginald F. Lewis High School of Business and Law, Friendship Academy of Engineering and Technology,

New Era Academy in Baltimore City, and North County High School in Anne Arundel County. CFCC's TCP is in great demand by school principals, and the selection process is very competitive. Since then, the Montgomery County Council has provided funding for the Montgomery County State's Attorney's Office to operate the Truancy Prevention Program (TPP), which is based on the TCP. • June, 2015- CFCC introduces "Trails Over Truancy" program to the Truancy Court Program (TCP)

The TCP, in collaboration with Merritt Pridgeon, will introduce a new program to TCP participants in a Baltimore City Middle middle school. "Trails Over Truancy" will expose TCP students to classroom environmental activities and field trips to Robert E. Lee Park in Baltimore.

June, 2015- The Zanvyl and Isabelle Krieger Fund awards grant to CFCC's Truancy Court Program (TCP)

For the fourth consecutive year, the Zanvyl and Isabelle Krieger Fund has provided support for CFCC's Truancy Court Program (TCP). The Krieger Fund awarded \$15,000 to CFCC to continue operating the TCP in the 2015–2016 school year. The grant also helps support the operation of the TCP at North County High School in Anne Arundel County. The AOC has consistently appreciated the preventive power of the TCP to keep children out of the juvenile and child welfare systems and to keep parents out of the criminal justice system due to truancy.

June, 2015 - CFCC Director Barbara Babb receives the 2015 Stanley Cohen Distinguished Research Award

The Association of Family and Conciliation Courts (AFCC) bestowed the 2015 Stanley Cohen Distinguished Research Award on Professor Barbara Babb, director of the University of Baltimore School of Law Sayra and Neil Meyerhoff Center for Families,

Children and the Courts (CFCC), during their 52nd Annual Conference. The award recognizes outstanding research and achievements in family law. AFCC is an interdisciplinary, international association with more than 5,000 members. The award, named after one of AFCC's founders, recognizes outstanding research and achievements in family law. In his introduction of Professor Babb, AFCC Oregon Chapter Leader William Howe III noted her nationally- and internationally-recognized scholarship and activism to improve the family justice system, primarily through the creation of unified family courts.

• May 27-30, 2015 - CFCC presents at 52nd annual Association of Family and Conciliation Courts (AFCC) annual conference.

• March, 2015– CFCC awarded the William J. and Dorothy K. O'Neill Foundation Grant.

• January 2015 – CFCC published A Comprehensive Approach to Truancy for Baltimore City: A Roundtable Discussion, by Professor Barbara A. Babb and CFCC Senior Fellow Gloria Danziger.

CFCC has published <u>A Comprehensive Approach to Truancy for Baltimore City: A Roundtable Discussion</u>. The report is based on two roundtable meetings convened by CFCC that brought together city officials, school leaders, private and public agency heads, and other stakeholders in the education of Baltimore city's youth. The report provides recommendations to address the widespread truancy in Baltimore and other

cities where school attendance is a critical issue. It describes a collaborative citywide approach that encourages the development of best practices and offers a continuum of interventions for students who are missing school.

• November-December 2015 – In collaboration with the Association of Family and Conciliation Courts (AFCC), CFCC held two trainings for professionals who work with families and children.

November 30-December 1, 2015 – "Construction of an Effective Parenting Coordination Process: Structure, Tools and Techniques," with Debra K. Carter, PhD. This two-day training program was for parenting coordinators, mediators, lawyers, judges, therapists, parent educators, and other professionals who work with high conflict families.

 November 2015 –State Farm Insurance Good Neighbor Citizenship Program on Financial Literacy Workshops for Truancy Court Programs Schools

CFCC sponsored six workshops this Fall which were supported by a \$15,000 State Farm Good Neighbor Citizenship Grant. CFCC Student Fellows (second- and third-year University of Baltimore law students enrolled in CFCC's Student Fellows Program) developed workshop content for both parents and students in partnership with State Farm. The first workshops in the series, on November 2 and 4, focused on financial literacy skills and included presentations by State Farm agents David Rosario, John Buggs and Tom Benisch. The second workshops, November 9 and 11, provided students with information about opportunities for higher education and parents with information about how to help their children afford college. The third workshops, November 16 and 18, focused on job skills and the college admissions process.

• October 23, 2015 – CFCC Co-Hosted "Family Transitions: Issues, Solution and Policies" Conference.

CFCC co-hosted an interdisciplinary conference on October 23, 2015, to address issues affecting separating and divorcing families. Several hundred judges, lawyers, services providers, and other professionals attended the "Family Transitions: Issues, Solutions and Policies Conference," which consisted of five panels of experts from a wide range of disciplines. Panelists spoke about challenges, solutions, and policies relevant to

separating and divorcing families and their children. In addition, Dr. Robert Emery, a nationally recognized expert on children and divorce, and Delegate Katherine Dumais, Vice-Chair of the Maryland House of Delegates Judiciary Committee, provided keynote remarks. The conference was designed to launch a statewide conversation about the ways in which courts, policymakers, and services providers can better serve families in transition.

• June 1, 2015 – CFCC hosted "Maryland's Family Justice System: a Symposium."

CFCC collaborated with the Maryland Administrative Office of the Courts (AOC) to present "Maryland's Family Justice System: a Symposium" on June 1, 2015, at the University of Baltimore School of Law. The symposium featured keynote remarks by Maryland Chief Judge Mary Ellen Barbera, former Chief Judge Robert Bell, and Frank Kros, Executive Vice President of the Children's Guild of Baltimore City. Panelists focused on the successes and challenges of Maryland's family justice system since the establishment of the five Family Divisions in 1998. Symposium participants laid the groundwork for moving forward to address critical issues affecting families and children in family court.
